

# **Admissions Policy 2026**

Policy Type: Local Approved by: AQC

To ensure that the quality of provision for the students is maintained, the College has adopted the following Admissions Policy.

We wish to reaffirm the College's Mission to serve the local community and the surrounding area as a distinguished provider of education of the highest quality for the 16-19 sector. Within a framework of equality and diversity, the College encourages students of all abilities regardless of race and gender and welcomes applications from students with disabilities.

Applicants should note that each course has its own specific entry criteria as stated in the 'Courses' section on the College website.

The College will annually determine the number of spaces available for new admissions.

## **Entry Requirements**

Our entry requirements are set to give students a clear guide on the level of understanding, knowledge and skills they will need to achieve their best.

#### We require all students to have achieved at least 5 GCSEs at grade 4 or above.

We can accept one level 2 vocational qualification at Merit or above accompanied by at least 4 GCSEs at grade 4 or above to meet this minimum entry requirement. Please note that although, in many other contexts, a Pass at level 2 is considered equivalent to

a GCSE grade 4, for the purposes of admission to the College, the level 2 vocational qualification must have been achieved at Merit or above.

To access A level courses students will have mostly achieved grade 5s (or higher) across their GCSEs.

To access our vocational courses, students would generally achieve grade 4s or higher in their GCSEs.

Please note that, in addition to the minimum College/programme entry requirements, individual courses have specific grade entry requirements and this information is available on the website.

It is highly unlikely we will be able to offer a programme to students who have not achieved grade 4 in both Maths and English Language. If a student has not achieved a grade 4 in either GCSE English Language or Maths they will be required to have the course added to their programme of study. The absence of GCSE English Language at grade 4 will significantly restrict study programme options at level 3.

The College is not able to hold places on its courses for students who did not gain the necessary GCSE results, even if requesting a review of marking from the exam board. We recognise that for students affected in this way, this will be disappointing, but we will provide guidance and support for students to enrol on an alternative study programme.

We look at each student's GCSE results on an individual basis to ensure we guide them onto the most appropriate programme of study. Details of the requirements for specific types of programme and individual courses will be published on the website at the start of the 2025/26 admissions cycle.

## **Applications**

The College will only consider applications from students who are eligible for 16-19 funding, as outlined in the funding regulations at <a href="https://bit.ly/3T905z5">https://bit.ly/3T905z5</a>.

Applications are submitted online through the College website. There is a facility for monitoring the progress of an application online.

Applications from partner and non-partner schools are both welcome. The online application process will open on **Friday 3 October 2025 at 2pm.** 

## All applicants should apply by Monday 20 October 2025 at 4pm to be considered on time.

Please note that offers of interviews and subsequently places to study will be made in accordance with the information provided on the application and in accordance with

our Admissions Policy. However, should the information provided be incorrect, the College reserves the right to withdraw the offer of an interview and/or a place to study. Residency information provided on the application must be accurate and may be subject to verification by the College; this will be primarily through your current education provider.

#### On Time Applications (received by Monday 20 October 2025 at 4pm)

All applicants who have applied on time will be considered for, and are likely to be conditionally offered a place, subject to results and entry requirements and a satisfactory reference and interview.

## Procedure if the College is oversubscribed

The College is usually able to offer all on time applicants an interview. However, in the unlikely event that the number of on time applications received exceeds the number of offers that can be made, priority is given to applicants from the following groups.

- Applicants from partner schools (listed below) and schools within the same academy trust as the College;
- Applicants who currently have an Education Health and Care Plan;
- Children of current staff, college councillors and trustees of The Prospect Trust;
- Applicants who have a sibling currently attending the College or who have completed their course of study at the College within the previous two years;
- Young people in Care;
- During the 2025/26 academic year, applicants who are relocating to a
  permanent and primary residence to within a radius from the College which is
  10 miles or, if the College is oversubscribed, the maximum radius applied to
  the on-time applicants under the "Procedure if the College is oversubscribed"
  provision above.

Anyone outside of these groups will be considered in distance order<sup>1</sup> until capacity is met.

### Late Applications (received after Monday 20 October 2025 at 4pm)

All applications received after this date from the following groups will continue to be considered for interview:

- Applicants from partner schools and schools within the same academy trust as the College;
- Applicants who currently have an Education Health and Care Plan;
- Young people in care;
- During the 2025/26 academic year, applicants who are relocating to a
  permanent and primary residence to within a radius from the College which is
  10 miles or, if the College is oversubscribed, the maximum radius applied to
  the on-time applicants under the "Procedure if the College is oversubscribed"
  provision above.

#### Otherwise:

 Applications received after Monday 20 October at 4pm but before Wednesday 10 December at 4pm will go into a late reserve pool. In the event that we are able to select additional applicants from the late reserve pool, they will be selected in distance order from the College. The late reserve pool will close on Wednesday 10 December 2025 at 4pm. Applications received after Friday 5 December 2025 at 4pm but before
Wednesday 22 July at 4pm will go into a very late reserve pool. In the case that
we are able to select additional applicants from the very late reserve pool, they
will be selected in distance order from the College.

The system will close on **Wednesday 22 July at 4pm** after which point eligible late applicants must contact the College directly in order to make an application - <a href="mailto:admissions@farnborough.ac.uk">admissions@farnborough.ac.uk</a>.

Please note that selections can be made at any point during the application process. In the event that any selection is made from a reserve pool around the time of, or after, main College enrolment, selection may also be made on the basis of subject availability if individual courses are full.

#### **Student Transfers**

The College does not accept students transferring part way through a year or transferring from another institution into the second year of study.

#### **Interviews**

The College will send a Reference Form to the referee (ordinarily your current education provider) for completion prior to interviews.

All applicants will be informed whether they are to be offered an interview in due course through their online application and by email. For most applicants interviews will be held between November 2025 and March 2026.

## Offers of places and confirmation of acceptance

The College will endeavour to give all successful applicants an offer of a place as soon as possible after the interview. Within 14 days of the offer being made, applicants must confirm their acceptance or decline the offer via the application system. If applicants do not do this within the timeframe outlined we will assume that the place is declined.

## **Foreign Qualifications**

Applicants who have studied or are currently studying abroad, and are eligible to study at the College, will be required to apply and pay for a statement of comparability through UK ENIC. Students eligible for a place at the College will only be interviewed once the UK ENIC has been received. This will need to be presented at enrolment at the very latest.
